

**A chance to win a Signed England Men's or Women's Cricket Shirt with Toyota
(GB) PLC
Prize Draw Promotion
Terms and Conditions**

1. The Promoter

- 1.1 The promoter is: Toyota (GB) PLC (registered under company number 00916634 at Great Burgh, Burgh Heath, Epsom, Surrey KT18 5UX) (the “**Promoter**”).

2. The Promotion

2.1 The Promoter will be running a prize draw where participants will have the opportunity to win one of the following prizes (each a “Prize”):

- (a) 1x Signed England Men's Cricket shirt signed by either members of the England Men's Test Team, ODI Team or the T20 Team.
- (b) 1x Signed England Women's Cricket shirt signed by either members of the England Women's Test Team, ODI Team or the T20 Team.

2.3 The participant will have selected shirt they wish to enter for when completing the prize draw submission form.

2.4 Entries are not eligible for exchange for an alternative Prize.

2.5 The Promoter will select two (2) winners; each winner will have the ability to claim one Prize, each in accordance with these terms and conditions.

3. How to enter

3.1 The promotion will run from 12:00 on Wednesday 1 July 2026 (the “**Opening Date**”) to 12:00 on Wednesday 8 July 2026 (the “**Closing Date**”) inclusive.

3.2 To be eligible the participant must be:

- (a) an individual;
- (b) aged 18 years or over;
- (c) a UK resident;
- (d) registered on the Promoter's mailing list for communications involving cricket.

3.3 To enter the prize draw, participants must complete and submit the online entry form accessible via <https://www.toyota.co.uk/cricket/prize-draw> by the Closing

Date. As part of the entry process, participants will be required to provide their full name, email address, phone number.

- 3.4 All promotion entries must be received by the Promoter no later than 12:00 on the Closing Date. All promotion entries received after the Closing Date are automatically disqualified. Entries must include a valid email address where requested by the Promoter.
- 3.5 It is the responsibility of the participants to ensure that all information provided is accurate and complete.
- 3.6 No purchase necessary. There is no charge to participate.
- 3.7 The Promoter will **not** accept:
 - (a) responsibility for promotion entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure (if applicable), equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
 - (b) proof of posting (if applicable) or transmission as proof of receipt of entry to the promotion.
- 3.8 By participating in this promotion, you are agreeing to be bound by these terms and conditions.
- 3.9 The winners will be the entry selected at random from all correct eligible entries.

4. Eligibility

- 4.1 Subject to any other provisions of these terms and conditions, this promotion is open to all UK residents aged 18 years or over who are registered on the Promoter's mailing list for communications involving cricket, **except**:
 - (a) staff of the Promoter or staff of its holding or subsidiary companies;
 - (b) staff of agents or suppliers of the Promoter or its holding or subsidiary companies, who are professionally connected with the promotion or its administration; or
 - (c) members of the immediate families or households of (a) and (b) above.
- 4.2 In entering the promotion, you confirm that you are eligible to do so and eligible to claim and/or participate in any Prize you may win. The Promoter may require you to provide proof that you are eligible to enter the promotion.

- 4.3 The Promoter will not accept promotion entries that are:
- (a) automatically generated by computer or created by artificial intelligence (including but not limited to chatbots such as ChatGPT or similar software applications);
 - (b) completed by third parties or in bulk;
 - (c) illegible, have been altered, reconstructed, forged or tampered with;
 - (d) incomplete;
 - (e) false, misleading, fraudulent, derogatory, offensive or otherwise contrary to the spirit in which the promotion is conducted.
- 4.4 There is a limit of one entry to the promotion per person. Entries on behalf of another person will not be accepted and joint or multiple submissions are not allowed. Entries submitted via any automated or similar systems will not be accepted.
- 4.5 The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the promotion.

5. The Prize

- 5.1 The Prize is as follows:
- (a) 1x Signed England Men's Cricket shirt signed by either members of the England Men's Test Team, ODI Team or the T20 Team.
 - (b) 1x Signed England Women's Cricket shirt signed by either members of the England Women's Test Team, ODI Team or the T20 Team.
- 5.2 Prizes are subject to availability. There is no cash alternative available. The Promoter reserves the right to substitute the prize with a prize of equal or greater value.
- 5.3 The Prize cannot be exchanged for an alternative prize and is not negotiable or transferable.
- 5.4 The Promoter accepts no liability for missing signatures on the Prize.

6. Winners

- 6.1 The Promoter will draw two (2) winners of the Prizes at random from all eligible entries received by the Closing Date. Each winner being able to claim one Prize each.

- 6.2 The decision of the Promoter is final, and no correspondence or discussion will be entered into.
- 6.3 The Promoter will contact the winner as soon as practicable after 9:00 on 10 July 2026 (the “**Announcement Date**”) using the email address provided with the promotion entry to notify them that they are a winner of the Prize. It is the responsibility of the participant to ensure they check their “junk” folder for this notification.
- 6.4 If the Promoter is unable to contact the winner within (4) four days of the Announcement Date, a replacement winner will be selected at random from all remaining eligible entries. This process will be repeated until the Prize is fulfilled.

7. Claiming the prize

- 1.1 If you are the winner of the Prize, you will have (4) four days to claim the Prize. Instructions on how to claim the Prize will be set out in the notification e-mail received after the Announcement Date. If you do not claim the Prize by this date, your claim will become invalid.
- 2.1 Once the winner has claimed the Prize the Prize will be sent to the address provided by the winner.
- 3.1 Due to verification processes, the prize will be dispatched in October 2026. The Promoter will keep the winner informed of the progress.
- 7.1 The Prize may not be claimed by a third party on your behalf.
- 7.2 The Promoter will make all reasonable efforts to contact the winner. If a winner cannot be contacted, or is not available, or has not claimed their Prize within (4) four days of the Announcement Date, the Promoter reserves the right to offer the Prize to the next eligible participant selected from the correct entries that were received before the Closing Date. For the avoidance of doubt, in circumstances where a replacement winner is selected in accordance with this condition 7.5, the Promoter shall advise within the notification e-mail the number of days for the replacement winner to claim the Prize.
- 7.3 The Promoter does not accept any responsibility if you are not able to take up the Prize.

8. Limitation of liability

- 8.1 Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any

liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the negligence of the Promoter, its agents or distributors. Your statutory rights are not affected.

- 8.2 The Promoter will not be in breach of these Terms, nor be liable for any failure to comply with any of our obligations in connection with the promotion, if such breach or failure is caused by an event outside of our reasonable control. Events outside of our reasonable control include, but are not limited to, acts, omissions or failure of third parties, acts of god, natural disasters, fire, flood or collapse of buildings, epidemic or pandemic, terrorist attack, war, preparation for war or armed conflict, imposition of sanctions, any law or action taken by a government or public authority, IT and data security incidents (such as malware or ransomware attacks, denial of service attacks or other types of cyber attack), or interruption or failure of utility or telecommunications service. If we are unable to run the winner selection process within the period specified due to an event outside of our reasonable control, we will run the winner selection process once we are no longer inhibited by such an event.

9. Data protection and publicity

- 9.1 The Promoter will only process your personal information as set out in the <https://www.toyota.co.uk/footer/privacy-policy> and to the extent necessary to administer this Prize draw, including in the announcement of Winners, see section 6 of these Terms. Participants' personal data will be retained only for as long as necessary to administer the Prize draw, notify Winners, and comply with legal obligations. After the conclusion of the Prize draw and the distribution of the Prize, personal data will be securely deleted unless retention for a longer period is required by law.
- 9.2 By participating in the Prize draw, you consent to the processing of your personal data for the purposes of the administration of this Prize draw, including the use of third-party data processors where required. Your personal data will be processed solely for the purpose of facilitating the Prize draw and in accordance with our instructions and will not be shared with third parties for their own marketing purposes without your explicit consent. All third-party processors engaged in connection with the Prize draw are contractually bound by data protection obligations consistent with those of the Promotor. If you have opted in to receive marketing or further information from any of the Promoter's partners or other third parties involved in the Prize draw, you acknowledge and agree that those third parties will be responsible for the processing of your personal data and that such processing will be subject to their own privacy policies. The Promoter accepts no responsibility for how third parties process your data, and any queries or concerns should be addressed to them directly.

- 9.3 The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the Promoter will send the surname and county of the winner and, if applicable, copies of their winning entries to anyone that requests this information and emails toyotacrm@tgb.toyota.co.uk or writes to Toyota (G.B.) PLC, Great Burgh, Burgh Heath, Epsom, Surrey KT18 5UX with a stamped address envelope within one month after the Closing Date of the promotion.
- 9.4 If you object to any or all of your surname, county and winning entry being published or made available, you can restrict the processing of your personal data by emailing the Promoter at toyotacrm@tgb.toyota.co.uk. In such circumstances, the Promoter must still provide the information and winning entry to the Advertising Standards Authority on request.
- 9.5 The Promoter will only process your personal information as set out in the privacy policy: <https://www.toyota.co.uk/footer/privacy-policy> and to the extent necessary to administer this promotion.
- 9.6 All participants agree to the processing of their personal data by the Data Processor (Transform UK) for the purposes of the administration of this Prize draw.
- 9.7 Third-Party Data Processor. Transform has been engaged to assist in the administration of the Prize draw. Transform will process personal data solely for the purpose of facilitating the Prize draw and in accordance with our instructions. We ensure that all third-party processors are bound by data protection obligations consistent with our own, and personal data will not be shared with third parties for their own marketing purposes without explicit consent from participants. By participating in the Prize draw, you acknowledge and agree to the terms outlined in clause 9.1.

10. General

- 10.1 If there is any reason to believe that there has been a breach of these terms and conditions, the Promoter, at its sole discretion, reserves the right to exclude you from participating in the promotion at any stage.
- 10.2 The Promoter reserves the right to void, suspend, cancel, or amend the terms of this promotion at any stage and without notice if deemed necessary in their opinion,

and/or if circumstances arise outside of their control, with no liability to any participant or third party.

- 10.3 No third party can enforce these terms and conditions.
- 10.4 In the event of a conflict between these terms and any other terms or instructions related to this promotion, these terms and conditions take precedence.
- 10.5 These terms and conditions are governed by English law and are subject to the exclusive jurisdiction of the English Courts.
