

TOYOTA PART EXCHANGE- TERMS AND CONDITIONS

These terms govern the rules for using our part exchange tool.

"We" or "our" means Toyota (GB) PLC registered in England and Wales under company number 00916634, with registered office at Great Burgh, Burgh Heath, Epsom, Surrey, KT18 5UX.

The valuation tool and data provider is BCA.

1. Disclaimer

- 1.1. Nothing contained in or generated by the valuation tool shall be construed as creating any binding agreement, offer, or contract. The valuation provided is for informational purposes only, and we shall not be bound by, or have any legal obligation arising from, the valuation or any reliance placed upon it.

2. Tool Terms of Use

- 2.1. By using our tool, you confirm that you accept these terms and that you agree to comply with them.
- 2.2. The valuation tool may only be used for personal purposes, and the results may not be re-utilised or max-extracted in any way. We shall have no liability to you whatsoever for any losses arising out of your use of the valuation tool for commercial, business or re-sale purposes.
- 2.3. Our tool is made available free of charge. Although we make reasonable efforts to update the information on our tool, we make no representations, warranties or guarantees, whether express or implied, that the content on our tool is accurate, complete or up to date.
- 2.4. We do not guarantee that our tool, or any content on it, will always be available or be uninterrupted.
- 2.5. We may suspend or withdraw or restrict the availability of all or any part of our tool for business and operational reasons.
- 2.6. We may update and change our tool from time to time to reflect changes to our products, our users' needs and our business priorities. Every time you wish to use our tool, please check these terms to ensure you understand the terms that apply at that time.

3. Valuation Estimate

- 3.1. The valuation estimate given by this tool is indicative only, based on the information you have input. In no way does the valuation constitute an offer by us for purchase of the vehicle.
- 3.2. Valuations will be finalised following a physical appraisal, which may involve operational checks and a test drive. Following this, the value of your vehicle may increase, decrease or remain the same.

4. Assumptions used in Valuation

- 4.1. In calculating the valuation estimate of the vehicle, we have made the following assumptions, but only where you have not supplied the relevant information:
 - (a) The vehicle has never been in a major accident and is not categorised as insurance category C, D, N or S.
 - (b) The vehicle is not due a service in the next 1000 miles.
 - (c) The vehicle has a valid MOT certificate with at least a month remaining.
 - (d) The vehicle is not an import.
 - (e) The vehicle has not been used as a taxi or by a driving school or local authority.
 - (f) The vehicle has not been modified, either for appearance or performance.
 - (g) The odometer is a true representation of the vehicle's mileage and has not been manipulated in any way.
 - (h) You are the registered keeper with a valid copy of the V5C.
 - (i) There are no noticeable or known problems with the vehicle's steering, transmission, clutch, gearbox, suspension or brakes and all electrical items are functioning as expected.
 - (j) There are no warning lights illuminated.
 - (k) The tyres fitted to the vehicle meet the minimum legal standards.

If any of these assumptions do not apply to your vehicle or you have inputted incorrect information, the valuation estimate will not be accurate. To obtain an accurate valuation for your vehicle, please contact your local Toyota/Lexus dealership who will conduct a full appraisal of your vehicle before confirming a valuation.

5. Intellectual Property

- 5.1. The vehicle valuation tool is licensed to us for use on this website. You are granted a limited, non-exclusive, non-transferable right to access and use the tool solely for obtaining vehicle valuations for personal purposes.
